- 3. John Mazur began the meeting with the pledge of allegiance and a moment of silence and prayer for all deceased league officials, players and for all our troops around the world.
- 4. Ed Mullen reviewed the league financials. He reported that we have a \$5512.71 account balance as of 11/23/2019. Excess funds will be refunded to teams and some withheld for payments needed for 2020 season or used for credits for the 2019 season. League fee will be \$1300/team and payable by April 1st by all teams.
- 5. Kirk Tarabookia USSSA Umpire Assignor was present to discuss, assignments, arc-height enforcement, game costs, etc. Pitching arc to remain at 6'-12' height. Screen position and height to be enforced by umpires. 6'-10' arc vote denied (2y-10n).
- 6. Pitching screen tuck rule and 5' rule discussed. Warnings, implementation, consequences. (TBD)
- 7. Schedule and division format TBD in 2020. Kevin Wertz will coordinate with county.
- 8. Vote to return of \$100 fines to Menonna and Handelman. League is non-profit and no fines shall be implemented.
- 9. Clarify roster movement from initial week to the 3rd week of playing when rosters are frozen. Player movement in that period to be implemented by manager's release agreement and Board notified so master roster can be updated.

- 10. Elections of Officers (Postponed)
- 11. Rule 30: Implement a point system to determine regular season standings. (TBD)
- 12. Hard stop to the end of season date. (TBD)
- 13. Schedule suspended for the dates of NJSSA 50's tournament, Memorial Day, July 4th, and Labor Day weekends. (TBD)
- 14. No forfeit fines but infractions assessed based on rules 3,6,27,28,29.
- Minimum game requirement for playoffs. Recommendation is 5 weeks=10 games played out of 28 totals. Umpire of each game is required to make sure the picture of the scorebook is taken and sent to the league officer. (TBD)
- 16. Rule 17: Increase HR limit to 5, then 1 up 3 is way too limiting for A games (at least for A vs A Teams, vote best 2/3 votes from the A Team managers) (TBD)
- 17. Make senior bats available to players 65+ to level the playing field for those teams with older players. (TBD)
- 18. White line extending out from the pitcher's mound location. (TBD)
- 19. Only Managers speak with umpires: If a player other than the Manager continues to Violate this rule during the game, what should be the Penalty to the Player? (Warning then Ejection) (TBD)
- 20. Any protests must be immediately presented to the umpire and team managers prior to next pitch and not after game is over. (TBD)
- 21. League is run by the Managers. Rules, schedules, protests. grievances are voted on by the Managers.
- 22. Managers should vote on expected bad weather issues (i.e., pending severe weather during the summer 100+ degrees to avoid potential medical issues).
- 23. League is run by the Managers. Rules, schedules, protests. grievances are voted on by the Managers.
- 24. Managers should vote on expected bad weather issues (i.e., pending severe weather during the summer 100+ degrees to avoid potential medical issues).
- 25. Rules 89: pitching from behind the screen, 5' rule, possible tuck, no pitching from opposite side based upon which hand is used. (TBD)
- 26. Rule 13,14: change 65'to 70' bases and commit line. (TBD)
- 27. Rule 18: Flip/Flop rule (TBD)
- 28. List of exact costs of permits, insurance, softballs, umpires, assignor fees etc. costs to run the league. (Mullen)
- 29. Safety base 1B clarification. Only play at 1B a runner needs to touch the safety base. No play at 1B runner can touch either 1B bag.
