Baseball/Softball Field Use Rules and Regulations

- 1. Permits are non-transferable and non-refundable. Only the team/league listed on the permit may use the field.
- 2. Should the Parks Department cancel a game, for any reason, no one can use the field. ABSOLUTELY NO EXCEPTIONS! Should the Permit Holder choose to cancel a game, the Parks Department Ranger Division must be informed by 12:00 Noon on weekdays and 7:00 AM on weekends at (732) 745-3800. If we are not notified of the cancelation and you do not show up to the field, no refund or credit will be issued.
- 3. Only drop-down bases may be used on County Parks ball fields. Installation of "break-away" or stationary bases are strictly prohibited. Middlesex County does not supply bases.
- 4. Backstops may not be used for hitting practice.
- 5. Any league granted a permit for field usage, must submit a season schedule to the Office of Parks and Recreation within 2 weeks of paying for permit. A weekly update of your schedule must be faxed (732) 745-8209 to us by FRIDAY 12noon for the following week to ensure proper field maintenance.
- 6. The Permit Holder must supply the Office of Parks and Recreation with the name and phone number(s) of 2 reliable contacts for their organization, who can be reached during the week and on weekends.
- 7. To report any problems with the fields, call the Office of Parks and Recreation Administration Office (Weekdays 8:30-4:00 732-745-8205) or the Ranger Division (after hours, weekends or holidays, 732-745-3800).
- 8. If a player is seriously injured, call 911 and then call the Office of Parks and Recreation Ranger Division immediately at (732) 745-3800. A report must be filed.
- 9. Fields can only be used for the sport for which they were designed, i.e. baseball only on baseball fields, softball only on softball fields.
- 10. METAL SPIKES ARE STRICTLY PROHIBITED!
- 11. If lights are used, they will go off 15 mins after scheduled time but no later than 10:00PM unless otherwise noted. If rain occurs during game and game is canceled, please call Ranger Division (after hours, weekends or holidays, 732-745-3800) to shut lights off ASAP.
- 12. Failure to comply with any of these rules and regulations may result in loss of permit and/or the assessment of additional fees.
- 13. Insurance is required for use of our fields, a copy must be supplied to us prior to paying and picking up the permit.(Specific insurance requirements are listed on our website)
